



Brinton Golden's Flight Nanny Agreement

This agreement (“**Agreement**”), dated as of _____, 20__, is between _Kelsey Brinton or Robert Brinton_ (“**Breeder**” “**Flight Nanny**”), and _____ (“**Buyer**”). The subject of this Agreement is the below-described puppy/dog (“**puppy/dog/pet**”).

The Breeder and Buyer agree as follows:

- 1) All pets must be at least 8 weeks of age to be transported. The individual requesting or arranging for transport certifies that the pet being transported by Brinton Golden's is at least 8 weeks of age on or before transport pickup date. The person signing this form certifies the age of the pet to be at least 8 weeks old.
- 2) Scheduling—Length of transport. You understand that there is no guarantee or promise made as to the length of the time necessary to complete the transport of your pet. The duration of the transport is determined by routing, weather, and traffic conditions and could potentially last up to 24 hours. While this is rare, all efforts will be made to keep you informed and to keep your pet as comfortable as possible. We provide transport 24 hours a day, 7 days a week. You will be provided with estimated pick-up and delivery dates/times. We will make every effort to arrive at convenient times, however, scheduling changes and unforeseen delays beyond our control may occur.
- 3) Airline Issues- If the flight is cancelled because an airline issue, the airline will make every effort to reschedule at no cost but this may have to be coordinated with availability at our next available date. We will make every effort to make it as soon as possible
- 4) Pet is to be flown with flight nanny in cabin. Flight nanny agrees to take care and attend to all of the pets needs before and during flight and until pet is delivered to buyer. Including but not limited to proper hydration, feeding with quality kibble, and comfortable pet carrier. At no point will pet be stowed in under luggage compartment. If airline requests pet to be flown this way, other flights and arrangements will be made.
- 5) Brinton Golden's agrees to contact airline in advance to make airline aware of pet travel and to purchase pet ticket if needed. Flight Nanny agrees to follow all airline protocols and policy.
- 6) Buyer agrees to meet flight nanny at airport or other location decided upon beforehand. Buyer agrees to communicate with flight nanny and arrive to location on time. Late arrival of the buyer that results in missed flight for flight nanny will result in a fine of \$500 in order for flight nanny to book a new flight and make hotel accommodations if necessary.
- 7) Breeder agrees that any pet being transported is healthy and cleared by a veterinarian no more than 10 days in advance. Breeder acknowledges that the pet will be current on vaccinations.

8) Buyer agrees to pay Brinton Golden's a fee of \$ _____ for flight nanny services. Payment must be made in full in order for travel arrangements be made and tickets to be purchased. Quoted price is valid for 48 hours. In the event the 48 hours has elapsed pricing is subject to change based on flight cost and availability. Fee may be paid via Venmo, Paypal, or Credit Card.

9) If flight nanny has to cancel flight for personal reasons not pertaining to weather or travel circumstances, flight nanny agrees to make new travel arrangements at the cost of the breeder. Furthermore if buyer has to cancel after purchase of tickets are made there will be no refunds given and buyer will agree to pay any additional costs to reschedule.

10) Buyer agrees to provide safe measures in transporting the pet home. (Ex. Crate, travel carrier, or additional person) The travel carrier used by the flight nanny is the breeders possession and will not be given or included in the flight delivery.
